

## MARION POPCORN FESTIVAL CRAFT SHOW CONTRACT

**DATES:** SEPTEMBER 4, 5, AND 6, 2008

**SPACE RENT:** SPACES ARE 10' X 10' AT A FEE OF \$125.00 PAYABLE TO THE MARION POPCORN FESTIVAL, P. O. BOX 1011, MARION, OHIO 43301-1011. 50% OF SPACE FEE IS DUE BY JUNE 30, 2008 WITH BALANCE IN FULL BY JULY 31, 2008. NO REFUNDS OF DEPOSIT AFTER AUGUST 10, 2008. NO REFUNDS IF SELLER DOES NOT ATTEND THE EVENT.

**SPACE ASSIGNMENTS:** ASSIGNMENTS WILL BE MADE BY THE COMMITTEE AT THE TIME PAYMENT IS RECEIVED IN FULL.

**SETUP TIME:** WEDNESDAY, SEPTEMBER 3, 2008 BETWEEN 4:00 PM AND 8:00 PM OR THURSDAY AM AFTER 8:00 AM; READY TO OPEN BY 1100 AM. CONTACT CHAIRMAN TO DISCUSS ALTERNATIVE SETUP TIMES. HOURS OF OPERATION OF THE FESTIVAL ARE 11:00 AM TO 11:00 PM DAILY. APPLICANTS HEREBY AGREE TO REMAIN OPEN DURING THESE HOURS.

**BOOTHS & DISPLAYS:** ALL BOOTHS MUST BE OF PROFESSIONAL QUALITY AND APPEARANCE. ITEMS IN CRAFT AREA MUST BE 75% HANDMADE. ALL MATERIALS TO REMAIN WITHIN ASSIGNED SPACE. NO ALCOHOLIC BEVERAGES ALLOWED IN CRAFT AREA. ADULTS SHALL MAN BOOTHS AT ALL TIMES. NO CHILDREN ALLOWED IN BOOTH AREA. IT IS REQUIRED TO HAVE A LEGIBLE SIGN WITH YOUR NAME, ADDRESS, AND PHONE NUMBER AT YOUR BOOTH. ALL LICENSES REQUIRED ALLOWING THE CRAFTSMAN TO SELL OR MANUFACTURE HIS/HER PRODUCT IS THE SOLE RESPONSIBILITY OF THE APPLICANT. DEALERS ARE RESPONSIBLE FOR THEIR OWN BOOTH SECURITY. MPF WILL NOT BE RESPONSIBLE FOR ANY THEFT OR DAMAGE. ALL MATERIALS FOR BOOTH SETUP INCLUDING TENT, TABLES, COVERS, AND ELECTRIC CORDS (UL APPROVED 15 AMP POWER STRIP AND 200 FEET OF POWER CORD) ARE THE RESPONSIBILITY OF THE SELLER. ALL PRODUCTS WILL BE OF A FAMILY NATURE AND NON-OFFENSIVE, AND NONCOMMERCIAL. THE CHAIRMAN OF THE SHOW SHALL HAVE COMPLETE DISCRETION AS TO WHAT IS SALABLE AND ANYTHING DEEMED NOT SO SHALL BE REMOVED IMMEDIATELY.

**REFUSE & SANITATION:** ALL BOOTHS ARE TO BE KEPT NEAT AT ALL TIMES. REFUSE SHALL BE PLACED IN ASSIGNED AREA EACH NIGHT OR AS NEEDED. SPACES ARE TO BE TORN DOWN AND CLEARED FROM FESTIVAL GROUNDS IMMEDIATELY AFTER FESTIVAL CLOSES SATURDAY.

**HOLD HARMLESS AGREEMENT:** MARION POPCORN FESTIVAL SHALL ACCEPT NO RISK, WHATSOEVER, OR BE HELD LEGALLY OR OTHERWISE RESPONSIBLE FOR ANY AND ALL CLAIMS ARISING FROM THE SELLERS PARTICIPATION IN THE MARION POPCORN FESTIVAL. THE APPLICANT HEREBY RELEASES ANY AND ALL REPRESENTATIVES OF THE MARION POPCORN FESTIVAL FROM ANY LEGAL RESPONSIBILITIES WHATSOEVER. EACH APPLICANT ASSUMES TOTAL AND SOLE LEGAL RESPONSIBILITY FOR ANY AND ALL CLAIMS BROUGHT FORTH BY ANY PATRON, EMPLOYEE, FAMILIES, ETC. INCLUDING PERSONAL INJURIES OF ANY KIND SUSTAINED BY THE PUBLIC PERSONALLY OR OTHERWISE.
